- **\$100 non-refundable fee for a fresh tree and stand preset at your reserved tree location in the event hall.**
 - Requests are considered for tree heights of 5'– 6' or 6' -8' and we will do our best to honor your request but we reserve the right to substitute for a different sized tree due to available inventory.
 - Fresh trees will be treated with a wilt-proof agent and watered during the week by CWCR staff.
 - After tree spaces are assigned, sponsors will be notified of their location prior to the set-up date.
- **\$50 reduced fee; reserved tree location in the event hall, tree and stand provided by sponsor, not Angels.**
 - Fresh trees will be watered during the week by CWCR staff.
- **Tree spaces are 8' in diameter (marked) and approx. 8' tall. **Two spaces are required if you need more than 8'; the cost for the second space is \$50.00 and needs to be reserved and paid for in advance.***
- ***FIRM DEADLINE:* event program Tree write-up/description of 25 words or less is needed in electronic editable, in word format by **Monday, Dec. 1 by 8 pm, NO EXCEPTIONS. Email: *phillylphil@msn.com*****
 - Additional signage at the donor's expense is encouraged if you want a complete listing of what is included with your tree or have several donors/decorators to recognize. Signage needs to be placed under or next to your tree and cannot impede foot traffic or disrupt other displays.
 - Please verify the accuracy of the spelling of people's names and donated items before sending write-up for print.
- **One 120-volt, 10-amp outlet is available for each space.**
- **All ornaments must be fully secured to the tree with floral wire and ready for transport (no hot glue please).**
- **Angel's provides large plastic travel bags placed underneath stands of all trees to cover and prepare for transport.**
- **Sponsors are not to use the name of "Angel's Anonymous" to solicit items for donation.**
- **Angel's will be solely in charge of advertising and event-related tree signs except as mentioned above.**
- **Exhibitors will be respectful of other exhibitors, their space, and other displays.**
- **Children and families are invited during the free public viewing times only; children must be supervised.**
